CONSTITUTION

GENERAL

1. The articles in this Constitution are unalterable. These items represent the founding vision, goals and mission of the organization. If in the course of events, there is a desire to change these articles, the Society is to be dissolved, and a new society formed to replace it.

NAME

2. The Alberta Motorcycle Safety Society is the formal name of the Society. It will be referred to as “Alberta Motorcycle Safety Society”, or by the acronym “AMSS”.

3. Other terms may be used for specific events that are official events of the Society as best described by the activity, such as “Alberta Motorcycle Safety Society Poker Run” or other term which includes “Alberta Motorcycle Safety Society” which may be more relevant to the specific event. Only events that are officially sanctioned as part of AMSS operations may use the name in the title of the event.

4. The logo identified below is the only image that will be the AMSS identifier. Other images may include the name AMSS, which are used for specific safety campaigns – such as “Think Bike”, but this image is the sole logo as an AMSS identifier.



5. This logo will be black and white, or the colors may be inverted to product a white background with black lettering.

6. This logo may be reproduced by the Society for member use. The size of any patches shall not exceed 45 millimetres high by 105 millimetres wide. Patches will be worn on the sleeves of jackets or front of vests.

7. Any garments made by AMSS that include the logo may be larger than patches, and the logo will be on the front of any garments made.

8. This logo will not be worn as a back patch.

AUTHORITY FOR ESTABLISHMENT AND OPERATION

9. The Society is established under the authority of the *Societies Act* of the Province of Alberta. It shall be operated in accordance with regulations and authorities governing the operations of Not-for-profit/Non Profit organizations, the instructions contained within this constitution and the associated bylaws. In the context of this document, the *Societies Act of Alberta* may also be referred to as “*the act*”.

10. The Policies and Procedures outlined in the Society bylaws remain the final authority for all operations. The process for amendments of bylaws is detailed in the Society bylaws, and all provisions of the bylaws, are alterable by special resolution.

MISSION

11. The Society is dedicated to reduce serious injury and fatality statistics in the province of Alberta through partnerships with industry, media, government and community through the education of all road users on motorcycle safety and awareness via the creation and delivery of positive and high impact Public Service Announcements, to build a library of resources and be the hub of all motorcycle safety, awareness and educational needs.
